WHEREAS, thousands of evacuees have been displaced and are in need of aid due to the eruption of the Mayon Volcano;

WHEREAS, in times of extreme natural disasters, local government units need all the help they can muster to ease the burden and suffering of evacuees;

WHEREAS, Legazpi City extended financial assistance to Tuguegarao City when it was ravaged by Super Typhoon Lawin on October 19, 2016;

WHEREAS, in the spirit of reciprocity and as humanitarian gesture to fellow Filipinos in dire need of assistance, it is appropriate for Tuguegarao City Government to extend aid to Legazpi City.

NOW, THEREFORE, be it **RESOLVED**, as it is hereby **RESOLVED**, to grant financial assistance to Legazpi City in the amount of One Hundred Thousand Pesos (P100,000.00) to be charged against the Donations Account of the City Mayor.


