WHEREAS, Marawi City was under siege for many months due to its forcible occupation by the Maute Group;

WHEREAS, thousands of residents of Marawi City were displaced as a result of combat activities between government forces and the Maute Group in the fight to regain control and reinstall a legal government;

WHEREAS, in the aftermath of the Marawi City War, an extensive damage was incurred making the city's rehabilitation a monumental task needing assistance from benevolent sources;

WHEREAS, as kindhearted human beings and fellow Filipinos, it is but appropriate for the City Government of Tuguegarao to aid our distraught kindreds recover and rebuild from the ruins and ravages of war-torn Marawi City;

NOW, THEREFORE, be it **RESOLVED**, as it is hereby **RESOLVED**, to extend financial assistance to Marawi City Government in the amount of One Hundred Thousand Pesos (P100,000.00) as aid for its rehabilitation efforts, to be charged against the Donations Account of the City Mayor.




On joint motion, **CITY RESOLUTION NO. 039-2018** was **UNANIMOUSLY APPROVED** under suspended rules.
