CITY RESOLUTION NO. 040-2018

RESOLUTION AUTHORIZING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO ACCEPT DONATIONS AND SPONSORSHIPS FOR THE CAGAYAN VALLEY REGIONAL ATHLETIC ASSOCIATION (CAVRAA) MEET 2018

WHEREAS, Section 23 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides among other things that *“the local chief executives may, upon authority of the sanggunian, negotiate and secure financial grants or donations in kind, in support of the basic services or facilities enumerated under Section 17 hereof, from local and foreign assistance agencies without necessity of securing clearance or approval therefor from any department, agency, or office of the national government or from any higher local government unit”*;

WHEREAS, Tuguegarao City Government will host the 2018 Cagayan Valley Regional Athletic Association (CAVRAA);

WHEREAS, the donations and sponsorships will be of great help to augment the budget of the City for the said hosting of CAVRAA Meet 2018;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano requested the Seventh City Council for an authority to accept donations and other forms of assistance;

WHEREAS, the Seventh City Council, after an exhaustive discussion and thorough deliberation during its 71th Regular Session, found the request to be in order, necessary and urgent;

WHEREAS, all monies/any form of assistance should be properly receipted and inventoried by the Office of the City Treasurer, subject to the usual accounting and auditing rules and procedures, and

that the City Mayor, Hon. Atty. Jefferson P. Soriano, shall submit a Report thereto to the Seventh City Council.




