CITY RESOLUTION NO. 041-2018

RESOLUTION RECOMMENDING THE APPROVAL OF THE MEMORANDUM OF AGREEMENT AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE LOCAL GOVERNMENT OF TUGUEGARAO CITY THE MEMORANDUM OF AGREEMENT WITH THE NORTHWESTERN EYE CENTER

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has requested for an authority to sign the Memorandum of Agreement, for and on behalf of the Tuguegarao City Government with Northwestern Eye Center;

WHEREAS, the Northwestern Eye Center seeks the assistance of the Tuguegarao City Government through the Tuguegarao City People's General Hospital (TCPGH) in providing emergency transport service during emergency cases only;

WHEREAS, the Memorandum of Agreement is a requirement of the Department of Health (DOH) in the renewal of their license to operate;

WHEREAS, the said request has been referred to the Committee on Health and Sanitation;

WHEREAS, amendments were introduced by members of the committee on the Memorandum of Agreement, adopting a similar Memorandum of Agreement entered into by the Local Government of Tuguegarao City between Eye Can Philippines, Inc. which was earlier approved by the Seventh City Council. The Memorandum of Agreement shall commence from February 01, 2018 to December 31, 2018, and renewable every after a year. The Committee finds the same to be in order and beneficial for the Tuguegarao City Government and favorably recommends the approval of the Memorandum of Agreement and granting authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on


behalf of the Local Government of Tuguegarao City the Memorandum of Agreement with Northwestern Eye Center.




