CITY RESOLUTION NO. 047-2018

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) AMONG THE BUREAU OF FISHERIES AND AQUATIC RESOURCES, REGIONAL OFFICE NO. 02 (BFAR R02), THE PROVINCIAL LOCAL GOVERNMENT UNIT OF CAGAYAN (PLGU-CAGAYAN) AND BARANGAY CENTRO 09 OF TUGUEGARAO CITY FOR THE MOTORIZED FLAT-BOTTOM FIBERGLASS FISHING BOAT AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN THE SAID MOA FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT

WHEREAS, one of the essential objectives of the Bureau of Fisheries and Aquatic Resources (BFAR) is to increase fish farmers' production and profitability;

WHEREAS, the fabrication of Fiberglass boats minimize the use of lumber and wood materials thus contributing to the conservation of our forests notwithstanding the longer lifespan of fiberglass boats due to their resistance to rotting and wood-boring marine worms and pests that are common occurrence among traditional wooden boats;

WHEREAS, one of the purposes of BFAR RO2 in providing fiberglass fishing boats is to sustain the livelihood to the marginalize fisherfolk;

WHEREAS, the BFAR has programmed practicum projects to harness the potential and showcase the feasibility and profitability of environment-friendly capture technology;

WHEREAS, the Committee on Agriculture and Food met on February 01, 2018 to deliberate on the subject referral titled "*Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Bureau of Fisheries and Aquatic Resources, Regional Office No. 02 (BFAR R02),*

Provincial Local Government Unit of Cagayan (PLGU-Cagayan) and Barangay Centro 09 of Tuguegarao City, Cagayan for the Motorized Flat-Bottom Fiberglass Fishing Boat”;


WHEREAS, the committee finds the terms and conditions on the Memorandum of Agreement to be in order and beneficial to the constituents of Tuguegarao City.
