CITY RESOLUTION NO. 066-2018

**A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY.
JEFFERSON P. SORIANO, FOR THE SUSPENSION OF CLASSES FOR ALL LEVELS
IN TUGUEGARAO CITY ON FRIDAY, FEBRUARY 23, 2018
BY WAY OF AN EXECUTIVE ORDER**

WHEREAS, Section 16 of the Local Government Code of 1991 on General Welfare states that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;"

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, endorsed to the Seventh City Council the request of the Schools Division Superintendent, Dr. Denizon P. Domingo, for the suspension of classes in Tuguegarao City in all levels on February 23, 2018 in view of the 2018 Cagayan Valley Regional Athletic Association (CAVRAA) Meet Opening Ceremonies;

WHEREAS, the said indorsement was discussed and deliberated during the 73rd Regular Session of the Sangguniang Panlungsod held on February 20, 2018;

WHEREAS, the Opening Ceremonies of the 2018 CAVRAA Meet to be held at Cagayan Sports Complex will be held on 23 February 2018 at 4 o'clock in the afternoon;

WHEREAS, the opening ceremonies will be preceded by a Parade of Athletes and Delegation Officials around the City;



WHEREAS, in order to ensure a free and orderly flow of traffic and to allow the students and academic community to watch the spectacle, there is a need to declare Friday, 23 February 2018, a “No Classes” day in Tuguegarao City;

WHEREAS, most elementary and secondary schools have already been occupied by the 2018 CAVRAA delegates.


NOW, THEREFORE, for and in consideration of the foregoing, **RESOLVE**, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, for the suspension of classes for all levels in Tuguegarao City on Friday, 23 February 2018, by way of an Executive Order.
