CITY RESOLUTION NO. 071-2018

RESOLUTION APPROVING THE CONTRACTS OF EMPLOYMENT SERVICES BETWEEN AND AMONG THE TUGUEGARAO CITY GOVERNMENT, THE CITY SCHOOLS DIVISION OFFICE AND WITH THE TEN (10) SERVICE CONTRACTORS OR INSTRUCTIONAL MANAGERS OF THE DEPARTMENT OF EDUCATION (DepEd) ALTERNATIVE LEARNING SYSTEM ACCREDITATION AND EQUIVALENCY (ALS A&E) SYSTEM AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID CONTRACTS OF EMPLOYMENT SERVICES

WHEREAS, Section 22(c) of Republic Act No. 7160, otherwise known as the Local Government Code, grants the power to the Local Chief Executive to enter into contracts on behalf of the local government unit with prior authorization by the sangguniang panlungsod;

WHEREAS, in support to the Alternative Learning System (ALS) Program of the Department of Education, the City Schools Division of Tuguegarao City has renewed the contract of ten (10) Service Contractors or Instructional Managers for the period of January 01, 2018 to December 31, 2018 with a monthly honorarium of Twelve Thousand Pesos (P12,000.00) each to be provided by the Tuguegarao City Government;

WHEREAS, it is necessary for the Tuguegarao City Government to enter into Contracts of Employment Services with the City Schools Division Office and with the following Service Contractors or Instructional Managers:

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, requested the Seventh City Council to grant him an authority to sign for and on behalf of the Tuguegarao City Government the said Contracts of Employment Services;

WHEREAS, after a deliberation in a committee meeting held for the said purpose, the joint committees of the Committee on Education and Committee on Rules, Laws and Ethics found the request to be in order and beneficial to the constituents of Tuguegarao City especially to the students of the ALS Program;

WHEREAS, the following amendments to the Contract were made during the 74th Regular Session held on February 27, 2018:

3. *That the Service Contractor is not entitled of other benefits accorded to regular government employees (such as PERA, COLA, Productivity, Separation Pay, and the like), however, they are duly accorded with Monthly Travel Allowance of One Thousand Five Hundred Pesos (P1,500.00), Performance Bonus and other incentives allowed by law.*

6. *That the First Party can terminate the contract of the Third Party for any violations of the responsibilities and functions stated above.*


NOW, THEREFORE, RESOLVE as it is hereby **RESOLVED** to approve the Contracts of Employment Services between and among the Tuguegarao City Government, the City Schools Division Office and with the ten (10) Service Contractors or Instructional Managers of the Department of Education (DepEd) Alternative Learning System Accreditation and Equivalency (ALS A&E) System and granting authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the said Contract of Employment Services.

RESOLVED FURTHER, to furnish copies of this Resolution to the City Mayor, Hon. Atty. Jefferson P. Soriano, Department of Education (DepEd), Tuguegarao City Schools Division Office, and the concerned service contractors or instructional managers, for their information and proper action.


