**RESOLUTION DESIGNATING THE CITY LEGAL OFFICE LOCATED AT THE GROUND FLOOR OF THE TUGUEGARAO CITY HALL AS THE TEMPORARY OFFICE OF THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO)**

**WHEREAS**, the Philippine Charity Sweepstakes Office (PCSO) is the principal government agency for raising and providing funds for health programs, medical assistance and services, and charities of national character;

**WHEREAS**, in order for PCSO to be more accessible to the people in Cagayan Valley and other nearby towns, its office should be located at the regional center in Tuguegarao City;

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, requested the Seventh City Council to pass a resolution designating the City Legal Office at the Tuguegarao City Hall Building as the temporary office space of PCSO;

**WHEREAS**, the Seventh City Council during their 75<sup>th</sup> Regular Session deemed it proper and necessary to grant the said request since this will be beneficial not only to the residents of Tuguegarao City but also to clients of nearby town and of the whole region.


