**RESOLUTION APPROVING THE PERMANENT RELOCATION AND PERMANENT
 INSTALLATION OF TRAFFIC LIGHT FROM JUNCTION TANZA-INTERSECTION
 TO CROSSING RIZAL STREET-COLLEGE AVENUE-BURGOS CARITAN ROAD
 AND BALZAIN ROAD**

WHEREAS, one of the priority projects of the present leadership of the City Mayor, Hon. Atty. Jefferson P. Soriano, is the installation of traffic lights along major streets to ease or lessen traffic problems;

WHEREAS, the City is currently on its experimental stage as regards the traffic lights already installed in some roads;

WHEREAS, the City Mayor requested the Seventh City Council to pass a resolution approving the permanent relocation and permanent installation of traffic light from junction Tanza – intersection to crossing Rizal Steert – College Avenue – Burgos Caritan Road and Balzain Road as recommended by the Tuguegarao City Traffic Management Group and the City Engineer’s Office;

WHEREAS, the Seventh City Council during their 75th Regular Session deemed it proper and necessary to grant the said request since it is beneficial not only to the residents of Tuguegarao City but also to all those who come to the city considering that this is the regional government center.



RESOLVED FURTHER, to furnish a copy of this resolution to the City Mayor, Hon. Atty. Jefferson P. Soriano, for information and proper action.


