CITY RESOLUTION NO. 079-2018

A RESOLUTION APPROVING THE SUPPLEMENTAL LOCAL DEVELOPMENT INVESTMENT PROGRAM (LDIP) CY 2018 AND SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) CY 2018

WHEREAS, the city priority Programs, Projects and Activities (PPAs) are embodied in the Executive-Legislative Agenda (ELA) CY 2016-2019 approved by the City Development Council in CDC Resolution No. 06, series of 2016 dated October 7, 2016 and adopted and approved by the 7th City Council in City Resolution No. 169-2016, also dated October 7, 2016;

WHEREAS, the Local Development Investment Program (LDIP) of Tuguegarao City CY 2017-2019 was approved by the City Development Council in CDC Resolution No. 17, series of 2017 dated October 10, 2017 and was adopted and approved by the 7th City Council in City Resolution No. 315-2017 dated November 14, 2017;

WHEREAS, a review of the ELA CY 2016-2019 and the LDIP CY 2017-2019 revealed that the following projects are items for supplemental investment programming:

WHEREAS, Local Budget Circular No. 116 provides the Guidelines on the Implementation of the Local Government Support Fund (LGSF)-Assistance to Cities in the FY 2018 General Appropriations Act (GAA), Republic Act No. 10964 while Local Budget Circular No. 117 provide the Guidelines on the Release and Utilization of the Local Government Support Fund-Financial Assistance to Local Government Units (LGSF-FA to LGUs) in the FY 2018 General Appropriations Act (GAA), Republic Act No. 10964;

WHEREAS, the City Development Council (CDC) convened on February 21, 2018 to approve and endorse the Supplemental Local Development Investment Program (LDIP) CY 2017-219 and Supplemental Annual Investment Program (AIP) CY 2018;

WHEREAS, after the approval thereof by the City Development Council, the same was endorsed to the 7th City Council for their appropriate review and approval;

WHEREAS, the 7th City Council has referred the matter to the Committee on Appropriations for their review and recommendation;

WHEREAS, the Committee recommends the adoption and approval of CDC Resolution No. 02;


WHEREAS, the Committee affirms that unless and until the programs, projects and activities (PPAs) embodied therein are funded, they cannot be considered final for implementation.
