CITY RESOLUTION NO. 087-2018

A RESOLUTION APPROVING THE REALIGNMENT OF THE APPROVED BUDGET COST OF THE PROJECT “CONSTRUCTION OF NEW ROAD” UNDER THE CY 2016 20% DEVELOPMENT FUND AMOUNTING TO TEN MILLION PESOS (P10,000,000.00)

WHEREAS, the City Mayor has requested the Seventh City Council for the realignment of the Approved Budget Cost of the project “Construction of New Road” under the CY 2016 20% Development Fund amounting to Ten Million Pesos (P10,000,000.00) for the concreting of the following roads:

WHEREAS, the Local Finance Committee has issued a Certification that the amount of Ten Million Pesos (P10,000,000.00) for the construction of New Roads under the 20% Development Fund Continuing Appropriation is free from any obligation and available for realignment;

WHEREAS, the said request was referred to the Committee on Appropriations and Committee on Infrastructure and Public Utilities;


