**CITY RESOLUTION NO. 091-2018**

**RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) WITH SCHOOLS, COLLEGES AND UNIVERSITIES FOR THE IMMERSION OF SENIOR HIGH SCHOOL STUDENTS AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA**

**WHEREAS**, Section 22 (c) of Republic Act 7160, otherwise known as the Local Government Code, grants the power to the Local Chief Executive to enter into contracts on behalf of the local government unit with prior authorization by the sanggunian concerned;

**WHEREAS**, in support to the endeavors of Senior High School students studying in any school, college or university in Tuguegarao City, the Tuguegarao City Government allows work immersion which is a part of their curriculum in order for them to be familiarized with the workplace and for employment simulation;

**WHEREAS**, the schools, colleges and universities regard Tuguegarao City Government as one of the best training grounds for the students to acquire the necessary knowledge, skills and attitudes in their chosen field of specialization;

**WHEREAS**, the first two (2) schools which have requested for the work immersion of their Senior High School students are the University of Saint Louis Tuguegarao (USLT) for a period of at least forty (40) hours and the University of Cagayan Valley (UCV) for a period of eighty (80) hours of ten (10) working days training;

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, requested the Seventh City Council to approve the Memorandum of Agreement (MOA) with schools, colleges and universities for the immersion of Senior High School students and to grant him an authority to sign for and on behalf of the Tuguegarao City Government the said MOA;

**WHEREAS**, after a deliberation in a committee meeting held for the said purpose, the Committee on Education found the request to be in order and beneficial;

**WHEREAS**, upon the presentation and adoption of Committee Report No. 051-2018, the Seventh City Council during their 77<sup>th</sup> Regular Session deemed it proper and necessary to approve the herein request.


**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement (MOA) with schools, colleges and universities for the immersion of Senior High School students and grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the said MOA.
