RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) REGION 02 FOR THE IMPLEMENTATION OF THE DOLE KABUHAYAN PROGRAM AND AUTHORIZING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF AGREEMENT

WHEREAS, pursuant to Department Order No. 137, series of 2014, the Department of Labor and Employment (DOLE) will provide a capacity building facility on livelihood and entrepreneurial ventures for the workers in the informal economy and the vulnerable groups of workers such as parents of child laborers, women, youth, persons with disabilities, indigenous peoples, among others, under the DOLE Kabuhayan Program;

WHEREAS, the DOLE Region 02 has been given the responsibility to implement the DOLE Livelihood (Kabuhayan) Program to enable the unemployed poor, seasonal and low-wage workers to start individual livelihood or collective enterprise undertakings with the goal of moving them out of poverty and making them productive;

WHEREAS, the DOLE Region 02 shall implement the foregoing livelihood intervention in the City of Tuguegarao, Province of Cagayan, in partnership with the LGU-Tuguegarao City as accredited co-partner;

WHEREAS, this partnership is vital to ensure the successful implementation of the said projects and achieve their desired social outcomes;

WHEREAS, Tuguegarao City has been accredited by the Department of Labor and Employment (DOLE) Region 02 to be capable in implementing the proposed project of the twenty-seven (27) beneficiaries located in the various barangays of Tuguegarao City.


