CITY RESOLUTION NO. 108-2018

RESOLUTION SIGNIFYING THE SUPPORT OF THE TUGUEGARAO CITY GOVERNMENT TO THE PROPOSED PROJECT OF THE PROVINCIAL GOVERNMENT ALONG NATIONAL HIGHWAY FRONTING PROVINCIAL CAPITOL COMPOUND (ALONG TUGUEGARAO BYPASS ROAD AND PUZON STREET) UNDER THE NATIONAL ROAD LIGHTING PROGRAM

WHEREAS, one of the projects of the Provincial Government requested for funding is the National Road Lighting Program that includes among others the National Highway fronting Provincial Capitol Compound (along Tuguegarao Bypass Road and Puzon Street);

WHEREAS, in order for the herein-stated project to be possibly included in the list of projects to be subjected for evaluation by the DPWH-RPO, there is a need for a Sangguniang Panlungsod resolution as a way of supporting the same;

WHEREAS, the Hon. Manuel N. Mamba, Governor, Province of Cagayan, requested the City Mayor, Hon. Atty. Jefferson P. Soriano, to facilitate the passage of the said resolution, the same of which the latter indorsed to the Seventh City Council for preferential and immediate action;

WHEREAS, after an exhaustive deliberation and discussion, the Seventh City Council during their 79th Regular Session deemed it proper, necessary and beneficial to approve herein request.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to signify the support of the Tuguegarao City Government to the proposed project of the Provincial Government along National Highway Fronting Provincial Capitol Compound (along Tuguegarao Bypass Road and Puzon Street) under the National Road Lighting Program.




On motion of Hon. Raymund P. Guzman and without any objection, **CITY RESOLUTION NO. 108-2018** was **APPROVED** under suspended rules.


