**RESOLUTION AMENDING CITY RESOLUTION NO. 195-2017 TITLED “A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. BIENVENIDO C. 


On joint motion, **CITY RESOLUTION NO. 113-2018** was **APPROVED** under suspended rules.
