WHEREAS, the Committee on Appropriations reviewed the Annual Budget of Barangay Centro 08 for CY 2018;

WHEREAS, the Annual Budget of Barangay Centro 08 for CY 2018 has complied with the established budgetary requirements as certified by the Local Finance Committee and the same was validated by the Committee on Appropriations.

WHEREFORE, RESOLVE, as it is hereby RESOLVED, to approve the Barangay Annual Budget for Calendar Year 2018 of Barangay Centro 08 in the amount of P1,463,435.00 with the condition that all disbursements shall be in accordance with prescribed guidelines.

RESOLVED FURTHER, to prioritize the allocation of funds for Solid Waste Management Program in the ensuing Barangay Supplemental Budget for CY 2018 in compliance to R.A. 9003, otherwise known as the Solid Waste Management Act.
