RESOLUTION APPROVING THE TRANSFER OF NINE (9) UNUSED STREETLIGHTS ALONG BARANGAY TANZA TO THE BOUNDARY OF BARANGAY CENTRO 04 AND BALZAIN EAST (ALONG ADRINELS) TUGUEGARAO CITY

WHEREAS, one of the top priority projects of the present administration is the installation of streetlights for Tuguegarao City;

WHEREAS, the Honorable City Mayor, Atty. Jefferson P. Soriano, indorsed to the Seventh City Council the request of Engr. Francisco Lingan, Jr., Head, Infrastructure Projects Unit of the City Engineer's Office, for the transfer of nine (9) unused streetlights along Barangay Tanza to the boundary of Barangay Centro 04 and Balzain East (along Adrinels) Tuguegarao City;

WHEREAS, pursuant to Committee Report No. 64-2018 of the Committee on Infrastructure and Public Utilities, the Seventh City Council during their 81st Regular Session deemed it proper, necessary and beneficial to approve the herein request.
