**CITY RESOLUTION NO. 118-2018**

**RESOLUTION APPROVING THE TUGUEGARAO CITY CY 2011, 2014 AND 2015  
 EXCISE TAX UTILIZATION**

**WHEREAS**, Local Budget Memorandum No. 76 dated October 6, 2017 provides for the guidelines and procedures on the release and utilization of the shares of cities and municipalities within a beneficiary province from CY 2011, 2014 and 2015 collection of burley and native tobacco excise tax pursuant to Republic Act No. 8240, as amended by Republic Act No. 10351;

**WHEREAS**, Local Budget Memorandum No. 76 dated October 6, 2017 also provides the names of the cities and municipalities and their respective shares in the beneficiary province from CY 2011, 2014 and 2015 collection of burley and native tobacco excise tax under Republic Act No. 8240, as amended, chargeable against the FY 2016 GAA, Republic Act No. 10717, Continuing Appropriations;

**WHEREAS**, Tuguegarao City has been included as one of the beneficiaries with a total share of Forty-Four Million One Hundred Sixty Four Thousand Six Hundred Eight Pesos (P44,164,608.00);

**WHEREAS**, the Tuguegarao Tobacco Producers Cooperative, facilitated by the City Mayor and the City Agriculturist's Office, deliberated and agreed on February 10, 2018 at Libag Sur Barangay Gymnasium on the utilization of the CY 2011, 2014 and 2015 Excise Tax Share;

**WHEREAS**, the City Development Council (CDC) convened on April 02, 2018 to approve and endorse the CY 2011, 2014 and 2015 Excise Tax Utilization as follows:

**WHEREAS**, the said request for approval on the proposed Excise Tax Utilization was referred to the Committee on Appropriations;




