**CITY RESOLUTION NO. 120-2018**

**RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO NEGOTIATE FOR THE PURCHASE OF PARCELS OF LANDS FOR THE VARIOUS INFRASTRUCTURE PROJECTS OF THE TUGUEGARAO CITY GOVERNMENT**

**WHEREAS**, the City Mayor has requested an authority from the Seventh City Council to purchase lands for the various infrastructure projects of the Tuguegarao City Government;

**WHEREAS**, the Committee on Appropriations, to which the matter has been referred, met and deliberated on the matter on April 12, 2018;

**WHEREAS**, it has been agreed upon by the committee members that subject to the approval of the city council, the City Mayor will be given the authority to negotiate for the purchase of lands on the following purposes:

- a. Hospital
- b. Auction Market
- c. Motorpool
- d. Evacuation/Rehabilitation Center
- e. Convention Center

**WHEREAS**, it has been further agreed that the purchase shall be subject to the condition that the lot to be purchased be suitable for the construction of the above-mentioned infrastructure projects and on the basis of the existing market price and zonal valuation of the Bureau of Internal Revenue (BIR);


**WHEREAS**, after a thorough review of the said request and after finding the same to be in order, the committee recommends for the passage of a Resolution Granting authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to negotiate for the purchase/acquisition of lots for the said infrastructure projects.

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to negotiate for the purchase of parcels of lands for the aforementioned infrastructure projects.


