**WHEREAS**, the list of Punong Barangays and Sangguniang Kabataan Chairs who underwent drug-testing will be posted;


**WHEREAS**, the City Government of Tuguegarao will sponsor the expenses of drug-testing and the City Health Office will conduct the examination.
