**WHEREAS**, the Annual Budget of Barangay Gosi Norte for CY 2018 has complied with the established budgetary requirements as certified by the Local Finance Committee and the same was validated by the Committee on Appropriations.

**WHEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to approve the Barangay Annual Budget for Calendar Year 2018 of Barangay Gosi Norte in the amount of P1,755,000.00 with the condition that all disbursements shall be in accordance with prescribed guidelines.






