RESOLUTION APPROVING THE ANNUAL BUDGET OF BARANGAY GOSI NORTE FOR CY 2018

WHEREAS, the Sangguniang Panlungsod or Sangguniang Bayan is empowered to review all barangay ordinances authorizing annual appropriations as mandated in Chapter III, Article 2, Section III of the Local Government Code of 1991;

WHEREAS, the Committee on Appropriations reviewed the Annual Budget of Barangay Gosi Norte for CY 2018;

WHEREAS, the Annual Budget of Barangay Gosi Norte for CY 2018 has complied with the established budgetary requirements as certified by the Local Finance Committee and the same was validated by the Committee on Appropriations.

WHEREFORE, RESOLVE, as it is hereby RESOLVED, to approve the Barangay Annual Budget for Calendar Year 2018 of Barangay Gosi Norte in the amount of P1,755,000.00 with the condition that all disbursements shall be in accordance with prescribed guidelines.

RESOLVED FURTHER, to prioritize the allocation of funds for Solid Waste Management Program in the ensuing Barangay Supplemental Budget for CY 2018 in compliance to R.A. 9003, otherwise known as the Solid Waste Management Act.
