CITY RESOLUTION NO. 129-2018

A RESOLUTION APPROVING THE MEMORANDUM OF UNDERTAKING BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE ENVIRONKONSULT EQUIPMENT AND SERVICES, INC. FOR THE SEPTAGE MANAGEMENT PROGRAM AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF UNDERTAKING

WHEREAS, the referral “*Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Undertaking with the Environkonsult Equipment Services, Inc. for the Septage Management Program*” was endorsed to the Seventh City Council;

WHEREAS, the Committee on Climate Change, Environmental Protection and Ecology met on April 18, 2018 to discuss the subject referral;

WHEREAS, in pursuant to R.A. 9275, the Philippine Clean Water Act of 2000, there is a need to protect and preserve the water bodies in the whole area of Tuguegarao City to pass the standards for affluent as mandated by the DENR-EMB. All water bodies must be treated first before they will be discharged through the Septage Management Program which is a requirement to all LGUs;

WHEREAS, in the Memorandum of Undertaking, the Environkonsult Equipment and Services, Inc. shall conduct a pre-feasibility study for the matter at hand which will cover the whole water bodies within the territorial jurisdiction of Tuguegarao City without cost on the part of the City Government;

WHEREAS, upon review of the referral, the Committee recommends for the adoption and approval of the Memorandum of Undertaking and a Resolution granting the City Mayor an authority to


sign for and on behalf of the Tuguegarao City Government the said Memorandum of Undertaking to be entered into with the Environkonsult Equipment and Services, Inc.
