CITY RESOLUTION NO. 130-2018

A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE DEPARTMENT OF INFORMATION AND COMMUNICATION TECHNOLOGY (DICT) ON THE USE OF THE ELECTRONICS BUSINESS PERMITS AND LICENSING SYSTEM (E-BPLS) SOFTWARE AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF AGREEMENT

WHEREAS, the referral “*Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Information and Communication Technology (DICT) on the use of the Electronics Business Permits and Licensing System (E-BPLS) software*” was endorsed to the Seventh City Council;

WHEREAS, the Joint Committee on Rules, Laws and Ethics and Committee on Public Information met on April 18, 2018 to discuss the subject referral;

WHEREAS, one of the services of the DICT is primarily to conduct E-BPLS which aims to create an online application of business permits;

WHEREAS, for the implementation of the system, the City Government will provide the hardware and the DICT will provide for the software;

WHEREAS, upon review of the referral, the Committees recommend for the adoption and approval of the Memorandum of Agreement and a Resolution granting the City Mayor an authority to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement to be entered into with the Department of Information and Communication Technology (DICT).


