CITY RESOLUTION NO. 131-2018

RESOLUTION AUTHORIZING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE CONTRACT OF LEASE FOR THE TUGUEGARAO CITY CENTRAL PUBLIC MARKET (DON DOMINGO) AND TUGUEGARAO CITY COMMERCIAL CENTER WITH STALL LESSEES

WHEREAS, Section 22(c) of Republic Act 7160, otherwise known as the Local Government Code, grants the power to the Local Chief Executive to enter into contracts on behalf of the local government unit with prior authorization by the sanggunian concerned;

WHEREAS, pursuant to the above-stated provision, the Tuguegarao City Government is allowed to enter into a contract of lease with private and public entities for the use of its facilities to fulfill its mandate to raise revenues to support its programs, projects and activities;

WHEREAS, the Tuguegarao City Government is the owner and operator of the Tuguegarao City Central Public Market (Don Domingo) and Tuguegarao City Commercial Center which have stalls ready for occupancy for lessees;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, requested the Seventh City Council for an authority to sign for and on behalf of the Tuguegarao City Government the contract of lease for the Tuguegarao City Central Public Market (Don Domingo) and Tuguegarao City Commercial Center with stall lessees;

WHEREAS, after a deliberation in a committee meeting held for the purpose, the joint committees of the Committee on Market and Committee on Rules, Laws and Ethics found the request to be in order and beneficial to the constituents of Tuguegarao City;

WHEREAS, the Seventh City Council during their 82nd Regular Session deemed it proper, necessary and beneficial to grant the said request with the amended contract of lease incorporated in City Ordinance No. 01-2011 titled "*An Ordinance Amending Chapter IV, Section 26, Paragraph "A" of Ordinance No. 01-2005, Otherwise Known as the "Tuguegarao City Public Market Code of 2005."*


