A RESOLUTION DIRECTING THE TUGUEGARAO CITY COUNCIL FOR THE PROTECTION OF CHILDREN (TCCPC) TO SUBMIT THEIR ACCOMPLISHMENT REPORT AND COMPREHENSIVE PLAN RELATIVE TO CHILDREN IN CONFLICT WITH THE LAW (CICL)

WHEREAS, Hon. Winnoco R. Abraham manifested during the Privilege Hour of the 81st Regular Session of the Seventh City Council held on April 17, 2018 the series of bicycle thefts in the city involving minors;

WHEREAS, the City Chief of Police, the City Social Welfare and Development Officer and the Market Administrator were invited to the 82nd Regular Session of the Seventh City Council held on April 24, 2018 to apprise the Body on the abovementioned thefts;

WHEREAS, a thorough discussion among the members of the Seventh City Council and resource persons regarding the issue ensued;

WHEREAS, in order to enact legislative measures to address the issues involving Children in Conflict with the Law (CICL), there is a need for the Body to study some documents from the Tuguegarao City Council for the Protection of Children (TCCPC).

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to direct the Tuguegarao City Council for the Protection of Children (TCCPC) to submit their Accomplishment Report and Comprehensive Plan relative to Children in Conflict with the Law (CICL).


RESOLVED FURTHER, to furnish a copy of this resolution to the Office of the City Mayor for information and appropriate action.
