**CITY RESOLUTION NO. 135-2018**

**A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE JUNKSHOP OWNERS ASSOCIATION AND GRANTING THE CITY MAYOR AN AUTHORITY TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF AGREEMENT**

**WHEREAS**, the referral "*Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, requesting for an authority to sign for and on behalf of the Tuguegarao City Government with the Junkshop Owners Association*" was endorsed to the Seventh City Council;

**WHEREAS**, the Committee on Rules, Laws and Ethics met on April 18, 2018 to discuss the subject referral;

**WHEREAS**, the City Government needs to renew the 2006 Memorandum of Agreement with the Junkshop Owners Association being one of the criteria in complying with its primary responsibility in the implementation and enforcement of the provisions of Republic Act No. 9003;

**WHEREAS**, upon review of the referral, the Committee recommends for the adoption and approval of the Memorandum of Agreement and a Resolution granting the City Mayor an authority to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement to be entered into with the Junkshop Owners Association.






