CITY RESOLUTION NO. 136-2018

A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN AND AMONG THE TUGUEGARAO CITY GOVERNMENT AND THE MEMBER-AGENCIES FOR THE ESTABLISHMENT OF THE CAGAYAN VALLEY CLIMATE CHANGE CONSORTIUM (CVCCC) AND GRANTING THE CITY MAYOR AN AUTHORITY TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF AGREEMENT

WHEREAS, the referral *“Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with Member-Agencies for the establishment of the Cagayan Valley Climate Change Consortium (CVCCC),”* was endorsed to the Seventh City Council;

WHEREAS, the Committee on Climate Change, Environmental Protection and Ecology to which the matter was referred to, met on April 30, 2018 to discuss the subject referral;

WHEREAS, Climate Change is an urgent concern in all sectors of the society and that it is a grave threat to the nation’s survival;

WHEREAS, the Cagayan Valley Region, specifically Tuguegarao City, is one of the most at risk cities in the world;

WHEREAS, the Consortium is simply established to function basically as a Coordinative Advisory, Policy and Management Body for Climate Change Adaptation and Disaster Risk Reduction and Management pursuant to National Law and R.A. 9729 “The Climate Change Act of 2009”, which is the National Framework and Strategy on Climate Change 2010 to 2022;

WHEREAS, the City Government as a Member is requested to provide a minimal financial support or in kind for the consortium’s operations and programs;


WHEREAS, upon review of the referral, the Committee recommends for the adoption and approval of the Memorandum of Agreement and a Resolution Granting the City Mayor an authority to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement to be entered into with Member-Agencies.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to grant the request for the approval of the Memorandum of Agreement between and among the Tuguegarao City Government and the Member-Agencies for the establishment of the Cagayan Valley Climate Change Consortium (CVCCC) and the passage of a corresponding Resolution granting authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement.




