**CITY RESOLUTION NO. 138-2018**

**A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN AND AMONG THE TUGUEGARAO CITY GOVERNMENT WITH THE BARANGAY LGU PARTNERS/ADOPTORS, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, REGIONAL OFFICE NO. 02 (DENR-RO2) AND PARTNER ADOPTORS FOR THE ADOPTION OF BALZAIN-CARITAN CREEK TO ENSURE SUSTAINABILITY OF THE ADOPT-AN-ESTERO PROGRAM AND GRANTING THE CITY MAYOR AN AUTHORITY TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF AGREEMENT**

**WHEREAS**, the referral *“Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Barangay LGU Partners/Adoptors, Department of Environment and Natural Resources, Regional Office No. 02 (DENR-RO2) and Partner Adoptors for the adoption of Balzain-Caritan Creek to ensure sustainability of the Adopt-an-Estero Program”* was endorsed to the Seventh City Council;

**WHEREAS**, the Committee on Climate Change, Environmental Protection and Ecology and Committee on Barangay Affairs met on April 18, 2018 to discuss the subject referral;

**WHEREAS**, that Balzain-Caritan Creek continues to deteriorate and its restoration requires the active participation of the community and meaningful collaboration with other sectors, specifically with respect to solid waste management, in order to ensure the continuous flow of water in the estero and prevent it from becoming a possible source of water-borne diseases and other threats to health, welfare and safety of the community;

**WHEREAS**, upon review of the referral, the Committees recommend for the adoption and approval of the Memorandum of Agreement and a Resolution granting the City Mayor an authority to sign for an on behalf of the City Government the said Memorandum of Agreement to be entered into with the


Barangay LGU Partners/Adoptors, Department of Environment and Natural Resources, Regional Office No. 02 (DENR-RO2) and Partner Adoptors.

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to grant the request for the approval of the Memorandum of Agreement between and among the Tuguegarao City Government with the Barangay LGU Partners/Adoptors, Department of Environment and Natural Resources, Regional Office No. 02 (DENR-RO2) and Partner Adoptors for the adoption of Balzain-Caritan Creek to ensure sustainability of the Adopt-an-Estero Program and the passage of a corresponding Resolution granting authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement.




