CITY RESOLUTION NO. 150-2018

RESOLUTION AUTHORIZING THE REPROGRAMMING OF SAVINGS FROM THE PROJECTS "ROAD CONCRETING" UNDER THE CONTINUING 20% DEVELOPMENT FUND CY 2016 IN THE AMOUNT OF ONE MILLION FIVE HUNDRED THREE THOUSAND THREE HUNDRED SEVENTY-FIVE PESOS AND SIXTY-SEVEN CENTAVOS (P1,503,375.67) FOR THE CONCRETING OF THE REMAINING UNPAVED ROAD ALONG PERPETUAL ROAD, UGAC NORTE, TUGUEGARAO CITY

WHEREAS, there are savings incurred from several completed projects "Road Concreting" under the Continuing 20% Development Fund;

WHEREAS, Engr. Francisco V. Lingan, Jr., Head, Infrastructure Projects issued a certification that the amount of One Million Five Hundred Three Thousand Three Hundred Seventy-Five Pesos and Sixty-Seven Centavos (P1,503,375.67) is a saving from the projects "Road Concreting" under the Continuing 20% Development Fund CY 2016, to wit:


WHEREAS, the approved Program of Work was duly submitted.


