WHEREAS, the City Government of Tuguegarao has been alarmed by rape cases committed in March and April of this year along Teresita Boulevard;

WHEREAS, Rowie Siddayao was identified to be the perpetrator of the said crimes;

WHEREAS, the Tuguegarao City Police Station has continuously conducted hot pursuit operation against the suspect Rowie Siddayao;

WHEREAS, on April 25, 2018, an informant informed the Tuguegarao City Police Station that the suspect was seen in Capatan, Tuguegarao City;

WHEREAS, upon receiving the said information, the Intel Operatives of the Tuguegarao City Police Station under the direct supervision of Police Superintendent Edward M. Guzman immediately proceeded to the referred place at around 3:00 o'clock in the afternoon;

WHEREAS, in view of the immediate response of the Tuguegarao City Police Station to the information they have received, the suspect Rowie Siddayao was apprehended and was brought to the police station at around 3:45 in the afternoon of the same day;




