CITY RESOLUTION NO. 159-2018

A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN AND AMONG THE TUGUEGARAO CITY GOVERNMENT, THE DEPARTMENT OF TRADE AND INDUSTRY, REGIONAL OFFICE NO. 02 (DTI-RO2) AND CAGAYAN PROVINCIAL MSMED COUNCIL FOR THE IMPLEMENTATION OF THE GO NEGOSYO ACT AND GRANTING THE INCUMBENT CITY MAYOR AN AUTHORITY TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF AGREEMENT

WHEREAS, the referral "Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Trade and Industry, Regional Office No. 02 (DTI-RO2) and the Cagayan Provincial MSMED Council for the implementation of the Go Negosyo Act" was endorsed to the Seventh City Council;

WHEREAS, the Committee on Rules, Laws and Ethics and Committee on Trade, Commerce and Industry met on May 22, 2018 to discuss the subject referral;

WHEREAS, the Department of Trade and Industry (DTI) with the support of the Local Government Unit (LGU) and other Non-Government Offices expect to further boost the assistance to Micro Small and Medium Enterprises (MSMEs) to grow and flourish with the city providing a venue where MSMEs can access the various services that are offered for its development;

WHEREAS, the LGU shall provide for the space or the area to house the negosyo centers pursuant to Go Negosyo Act specifically Section 4 which provides that "All negosyo centers shall be established in all provinces, cities and municipalities all over the country" and the DTI, on the other hand, will provide and pay for the staff to manage the said centers pursuant to Negosyo Act whose objective is to promote job generation through the development of MSMEs;



WHEREAS, upon review of the subject, the Committees recommend for the adoption and approval of the Memorandum of Agreement and a Resolution Granting the Incumbent City Mayor an authority to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement with the Department of Trade and Industry, Regional Office No. 02 (DTI-RO2) and the Cagayan Provincial MSMED Council for the implementation of the Go Negosyo Act.

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to approve the Memorandum of Agreement between and among the Tuguegarao City Government, the Department of Trade and Industry, Regional Office No. 02 (DTI-RO2) and the Cagayan Provincial MSMED Council for the implementation of the Go Negosyo Act and granting the incumbent City Mayor an authority to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement.

On motion of Hon. Raymund P. Guzman, duly seconded by Hon. Kendrick S. Calubaquib and without any objection, CITY RESOLUTION NO. 159 -2018 was APPROVED under suspended rules.
