CITY RESOLUTION NO. 160-2018

A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE PROVINCIAL GOVERNMENT OF CAGAYAN ON THE THREE MILLION PESOS DEVELOPMENT ASSISTANCE TO THE CITY FOR THE REHABILITATION OF SANITARY LANDFILL AND GRANTING AUTHORITY TO THE INCUMBENT CITY MAYOR TO SIGN THE SAID MEMORANDUM OF AGREEMENT

WHEREAS, the latest referral dated May 28, 2018 which is "*Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Provincial Government of Cagayan*" was endorsed to the Seventh City Council;

WHEREAS, the Committee on Rules, Laws and Ethics and Committee on Infrastructure met on May 10, 2018 and May 22, 2018 to discuss the subject referral;

WHEREAS, the documentary requirements such as the Memorandum of Agreement, Program of Work and the Certification by the City Accountant as to funds received from the Provincial Government fully liquidated in support of the Three Million Pesos Development Assistance were submitted by the Office of the City Mayor for the Rehabilitation of Sanitary Landfill Facility;


WHEREAS, upon review of the subject, the Committees recommend for the adoption and approval of the Memorandum of Agreement and the granting of authority to the City Mayor to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement between the Tuguegarao City Government and the Provincial Government of Cagayan on the Three Million Pesos Development Assistance to the City for the rehabilitation of Sanitary Landfill and granting authority to the Incumbent City Mayor to sign the said Memorandum of Agreement.
