CITY RESOLUTION NO. 186-2018

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT TO BE ENTERED BETWEEN THE LOCAL GOVERNMENT UNIT OF TUGUEGARAO CITY AND THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH) REGARDING THE ENROLLMENT OF JOB ORDER EMPLOYEES IN THE NATIONAL HEALTH INSURANCE PROGRAM (NHIP)-INFORMATION ECONOMY COVERAGE AND GRANTING AUTHORITY TO THE INCUMBENT LOCAL CHIEF EXECUTIVE TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF AGREEMENT

WHEREAS, the City Mayor has requested the Seventh City Council for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Philippine Health Insurance Corporation regarding the enrollment of job order employees in the National Health Insurance Program (NHIP)-Informal Economy Coverage;

WHEREAS, Section 5.3.a, Title III of the revised Implementing Rules and Regulations (IRR) of the National Health Insurance Act of 2013 states that "All other workers rendering services whether in government or private offices, such as job order contractors, project based contractors, and the like shall be covered under the Informal Economy of the Philippine Health Insurance Program";

WHEREAS, PhilHealth Board Resolution No. 2133, series of 2016 approves the mandatory coverage of individual/s, directly hired job orders (JOs) and project based contractors in the government as members of the Informal Economy, and authorizes government employers to withhold and remit their premium contributions as Individually Paying Members under the Group Enrollment Scheme;

WHEREAS, the Philippine Health Insurance Corporation (PhilHealth) has tapped the Local Government Unit of Tuguegarao City as their partner in the implementation of the program;

WHEREAS, the Tuguegarao City Government shall remit to PhilHealth the P200.00 monthly personal contribution of each member for purposes of providing each of them social protection or social health insurance.


NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement to be entered between the Local Government Unit of Tuguegarao City and the Philippine Health Insurance Corporation (PhilHealth) regarding the enrollment of job order employees in the National Health Insurance Program (NHIP)-Informal Economy Coverage.

RESOLVE FURTHER, to grant authority to the incumbent Local Chief Executive to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement.


