CITY RESOLUTION NO. 190-2018

RESOLUTION APPROVING THE REPROGRAMMING OF THE APPROVED BUDGET COST OF THE PROJECT "ROAD OPENING" UNDER THE CY 2017 20% DEVELOPMENT FUND CONTINUING APPROPRIATION IN THE AMOUNT OF TWENTY MILLION PESOS (P20,000,000.00) FOR THE CONCRETING AND OPENING OF ROADS WITHIN TUGUEGARAO CITY

WHEREAS, a continuing appropriation in the amount of Twenty Million Pesos (P20,000,000.00) was allocated under the 20% Development Fund of CY 2017 annual budget of Tuguegarao City for road opening within Tuguegarao City;

WHEREAS, the abovementioned project has not been implemented and is no longer feasible since it encountered problems in the acquisition of road right of way;

WHEREAS, the Local Finance Committee has certified that the amount of Twenty Million Pesos (P20,000,000.00) for road opening under the CY 2017 20% Development Fund continuing appropriation is free from any obligation;

WHEREAS, the City Mayor has requested that the above-cited continuing appropriation of Twenty Million Pesos (P20,000,000.00) shall be used instead for road opening along Taft Street, Barangay Centro 05 and for concreting of several unpaved roads within Tuguegarao City;

WHEREAS, there is a need to reprogram the amount of Twenty Million Pesos (P20,000,000.00) continuing appropriation allocated under the 20% Development Fund CY 2017 annual budget of Tuguegarao City for road opening of Carig-Enrile Boulevard-Bartolome Street, Caggay which is no longer

feasible in order that the same be utilized for the concreting of several unpaved roads and opening road along Taft Street, Centro 05 within Tuguegarao City;

WHEREAS, the abovementioned projects are duly supported by Programs of Work, Plans and Specifications.


NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the reprogramming of the approved Budget Cost of the project "Road Opening" of Carig-Enrile Boulevard-Bartolome Street, Caggay under the 20% Development Fund continuing appropriation CY 2017 annual budget of Tuguegarao City in the amount of Twenty Million Pesos (P20,000,000.00) for the opening and concreting of roads within Tuguegarao City, to wit:


