**CITY RESOLUTION NO. 196-2018**

**RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF INFORMATION AND COMMUNICATION TECHNOLOGY, REGIONAL OFFICE NO. 02 (DICT-RO2) FOR THE TECH4ED PROJECT AND GRANTING AUTHORITY TO THE ACTING CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT**

**WHEREAS**, the Department of Information and Communications Technology (DICT) endeavors to harness Information, Communication and Technology (ICT) skills of every Filipino through bringing digital literacy opportunities further to the countryside;

**WHEREAS**, the Department of Information and Communication Technology (DICT) is mandated to be the primary policy, planning, coordinating, implementing and administrative entity of the Executive Branch of the government that will plan, develop and promote the national ICT development agenda;

**WHEREAS**, in line with its mandate, the DICT aims to bridge the digital divide by establishing Tech4ED Centers under its Digital Community Program, which will enhance the socioeconomic condition of Filipinos and provide inclusive growth to the country;

**WHEREAS**, DICT has introduced the Tech4ED Project with its primary goal of building partnership to establish Tech4ED Centers that will serve as knowledge hubs. Tech4ED currently has eight (8) modules running: *e-EDUSKILLS, e-ASSIST, e-AGRI, m-MARKETPLACE, e-HEALTH, Gender and Development* and *Rural Impact Sourcing*;

**WHEREAS**, various segments of the Tech4ED Projects aim to cater to the Out-of-School Youths and Adults (OSYA), women, teachers, Overseas Filipino Workers (OFWs) as well as their families and

relatives, Persons With Disabilities (PWDs), senior citizens, indigenous people and entrepreneurs as their target beneficiaries or ENDUSERS;

**WHEREAS**, DICT and the LGU (collectively referred to as the “parties”) have agreed to cooperate and jointly commit in promoting community development through the use of information and communication technology for effective and efficient governance in the country, particularly of the program;

**WHEREAS**, the parties have agreed for the free use of the platform, technology and brand for Tech4ED Project under the conditions for the purpose of furthering the objectives of the project.


**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement with the Department of Information and Communication Technology, Regional Office No. 02 (DICT-RO2) for the Tech4ED Project and to grant authority to the Acting City Mayor, Hon. Bienvenido C. De Guzman II, to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement.


