CITY RESOLUTION NO. 198-2018

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE LOCAL GOVERNMENT UNIT OF TUGUEGARAO CITY AND THE DEPARTMENT OF HEALTH-DRUG ABUSE TREATMENT AND REHABILITATION CENTER (DOH-DATRC) AND AUTHORIZING THE INCUMBENT LOCAL CHIEF EXECUTIVE TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF AGREEMENT

WHEREAS, Section 51 of Republic Act 9165, otherwise known as the Comprehensive Drugs Act of 2002, has mandated Local Governments to appropriate substantial portion of their annual budgets to assist in or enhance the enforcement of RA 9165 giving priority to preventive or educational programs and rehabilitation of treatment of drug dependents;

WHEREAS, one laudable accomplishment of government under local authority is the improved coordination of programs and policies and the provision of technical assistance and material support to national government sponsored programs;

WHEREAS, the abovementioned legal mandate was reiterated under Section 9 of Dangerous Drugs Board (DDB) Regulation No. 4 Series of 2016;

WHEREAS, Section 74 of the Implementing Rules and Regulations (IRR) of RA 9165 lays down the guidelines for the Cost Sharing in the Treatment and Rehabilitation of a Drug Dependent;

WHEREAS, the Tuguegarao City Government in support of the Anti-Drug Campaign Program of President Rodrigo R. Duterte and in faithful compliance with the abovementioned legal mandates has drawn counterpart program by providing financial assistance to the resident patients of Tuguegarao City;

WHEREAS, as per information from Atty. Gloria Anastasha T. Lasam, Legal Officer of DOH-DATRC, there are seven (7) indigent resident-patients from Tuguegarao City confined in the Center for a minimum period of six (6) months while six (6) are in-patients and one (1) is out-patient;

WHEREAS, out of the Ten Thousand Pesos (P10,000.00) cost of treatment and rehabilitation, Five Thousand Pesos (P5,000.00) shall be shouldered by the Tuguegarao City Government and shall be sourced out from the city's annual budget for CY 2018 for Anti-Dangerous Drugs Campaign Program.


NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement to be entered between the Local Government Unit of Tuguegarao City and the Department of Health-Drug Abuse Treatment and Rehabilitation Center (DOH-DATRC) RO2.

RESOLVED FURTHER, to grant authority to the Incumbent Local Executive to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement.
