CITY RESOLUTION NO. 199-2018

**RESOLUTION URGING THE TUGUEGARAO CITY POLICE STATION AND ALL
 BARANGAY OFFICIALS OF TUGUEGARAO CITY TO ENFORCE AND IMPLEMENT
 PROVINCIAL ORDINANCE NO. 2015-08-004, OTHERWISE KNOWN AS
 "AN ORDINANCE REGULATING PILLION RIDING (MOTORCYCLE BACKRIDING)
 IN THE PROVINCE OF CAGAYAN"**

WHEREAS, the Sangguniang Panlalawigan of Cagayan passed and approved Provincial Ordinance No. 2015-08-004 titled "*An Ordinance Regulating Pillion Riding (Motorcycle Backriding) in the Province of Cagayan*" on July 22, 2015;

WHEREAS, the Acting City Chief of Police of Tuguegarao City, PSupt. George P. Cablarda, wrote a letter to the Office of the City Mayor requesting for the enactment of a city ordinance replicating the said provincial ordinance for its more effective implementation in the city;

WHEREAS, there is an alarming increase of crime rates perpetrated by riding-in-tandem criminals which require immediate and prompt action;

WHEREAS, considering that Tuguegarao City is within the territorial jurisdiction of the Province of Cagayan, all ordinances passed and approved by the Sangguniang Panlalawigan are enforceable within the City of Tuguegarao as well;

WHEREAS, the joint Committee on Public Safety and Order and Disaster Preparedness and Committee on Rules, Laws and Ethics deemed it proper to pass a resolution enforcing and implementing Provincial Ordinance No. 2015-08-004 instead of replicating the same.




On motion of Hon. Jude T. Bayona and without any objection, **CITY RESOLUTION NO. 199-2018** was **APPROVED** under suspended rules.
