**CITY RESOLUTION NO. 202-2018**

**A RESOLUTION AUTHORIZING THE INCUMBENT CITY MAYOR TO SOLICIT AND ACCEPT DONATIONS AND SPONSORSHIPS AND ENTER INTO CONTRACT OF SPONSORSHIP, MEMORANDUM OF AGREEMENT AND/OR CONTRACT OF SERVICE FOR THE 294<sup>th</sup> ANNUAL PATRONAL FIESTA KNOWN AS AFI FESTIVAL 2018**

**WHEREAS**, Section 23 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides among other things that “the local chief executives may, upon authority of the Sanggunian, negotiate and secure financial grants or donations in kind, in support of the basic services or facilities enumerated under Section 17 hereof, from local and foreign assistance agencies without necessity of securing clearance or approval therefor from any department, agency, or office of the national government or from any higher local government unit”;

**WHEREAS**, the Tuguegarao City Government will celebrate the 294<sup>th</sup> Tuguegarao City Annual Patronal Fiesta known as Afi Festival 2018 on August 8-16, 2018;

**WHEREAS**, the donations and sponsorships will be of great help to augment the budget of the City for the said celebration of the 294<sup>th</sup> Tuguegarao City Annual Patronal Fiesta “Afi Festival” 2018;

**WHEREAS**, the Acting City Mayor, Hon. Bienvenido C. De Guzman II, requested from the Seventh City Council for an authority to solicit and accept donations and sponsorships and other forms of assistance;

**WHEREAS**, the Seventh City Council, after a thorough deliberation during its Regular Session, found the request to be in order, necessary and urgent;




