**CITY RESOLUTION NO. 205-2018**

**RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN AND AMONG THE LOCAL GOVERNMENT UNIT (LGU) OF TUGUEGARAO CITY, DEPARTMENT OF EDUCATION, JOLLIBEE GROUP FOUNDATION, INC. AND CO-IMPLEMENTERS FOR THE JOLLIBEE GROUP FOUNDATION, INC. BUSOG LUSOG TALINO SCHOOL FEEDING PROGRAM AND GRANTING AUTHORITY TO THE INCUMBENT CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF TUGUEGARAO CITY THE SAID MEMORANDUM OF AGREEMENT**

**WHEREAS**, one of the objectives of the government is to address the serious problem of malnutrition in the country which greatly affects the lives of Filipino people, especially school children;

**WHEREAS**, in order to realize the said objective, the government through its different agencies continuously implements various nutrition activities and programs with private entities and non-government organizations as partners;

**WHEREAS**, in support to the nutrition programs of the government, the Department of Education (DepEd) in partnership with other agencies and non-government organizations implements the National Feeding Program that caters to the undernourished from Kindergarten to Grade VI pupils in public elementary schools through its School-Based Feeding Program (SBFP);

**WHEREAS**, the DepEd's School-Based Feeding Program is in partnership and collaboration with public and private entities which include Jollibee Group Foundation, Inc. for its Jollibee Group Foundation, Inc. Busog Lusog Talino School Feeding Kitchen that aims in mitigating hunger among school-aged children;

**WHEREAS**, the Schools Division of Tuguegarao City and the Local Government Unit of Tuguegarao City signified their intention to avail of the herein-stated program of Jollibee Group Foundation, Inc. and have satisfactorily met the application requirements of the foundation;

**WHEREAS**, the said program will be implemented for three (3) years, with 514 beneficiaries from eight (8) identified elementary schools in the City;

**WHEREAS**, the sharing of the funds will be One Million One Hundred Ten Thousand Two Hundred Forty Pesos (P1,110,240.00) as counterpart of DepEd-Tuguegarao to cover the daily feeding ingredients and operational cost at P18.00 per pupil for 120 days, honoraria of ten (10) volunteer parent of P100.00 per day for 120 days as counterpart of the Tuguegarao City Government chargeable from the City's Nutrition Funds and One Million Seven Hundred Sixty-Three Thousand Eight Hundred Forty Pesos (P1,763,840.00) from Jollibee Group Foundation, Inc.;

**WHEREAS**, the Acting City Mayor, Hon. Bienvenido C. De Guzman II, requested the Seventh City Council to approve the Memorandum of Agreement (MOA) and granting authority to the Incumbent City Mayor to sign for and on behalf of the Local Government Unit of Tuguegarao City the said MOA;

**WHEREAS**, after a deliberation in a committee meeting held for the said purpose, the Committee on Education found the request to be in order, with merit and beneficial to the constituents of the City;

**WHEREAS**, after a deliberation in a committee meeting held for the said purpose, the Committee on Education found the request to be in order, with merit and beneficial to the constituents of the City;



Busog Lusog Talino School Feeding Program and granting authority to the Incumbent City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Local Government Unit of Tuguegarao City the said Memorandum of Agreement.
