#### **CITY RESOLUTION NO. 207-2018**

RESOLUTION OF NO OBJECTION (RONO) APPROVING THE REQUEST OF SMART COMMUNICATIONS, INC. TO CONSTRUCT, INSTALL, OPERATE AND MAINTAIN A CELL SITE TOWER AND TELECOMMUNICATION FACILITIES AT THE LOT OWNED BY MR. AND MRS. JOEL S. NARAG LOCATED AT CARIG SUR, TUGUEGARAO CITY

WHEREAS, Smart Communications, Inc., a transnational corporation with business operation worldwide represented by Mr. Neil Jan Wayne L. Vinoya, submitted a letter request to the City Government of Tuguegarao for the approval of a construction, installation, operation and maintenance of a Cell Site Tower and Telecommunication Facilities in Carig Sur, Tuguegarao City;

WHEREAS, Smart Communications, Inc. has secured and submitted all required documents in compliance with the laws, policies and ordinances in the City of Tuguegarao;

WHEREAS, the Local Government of Tuguegarao through the City Engineering Office has conducted a site inspection on March 15, 2018 and a public consultation on February 22, 2018, wherein results showed that the neighboring areas within 50-meter radius interposed no objection on the construction of the SMART expansion project;

WHEREAS, the facility is found beneficial in the improvement of telecommunication services of the company to its clients in Tuguegarao City;

WHEREAS, non-compliance with the following requirements within six (6) months shall nullify this Resolution of No Objection:



## A. From the Center for Device Regulation, Radiation Health, and Research

- A perimeter fence or any appropriate structure must be constructed to prevent access of the public to the antenna.
- 2. Only authorized personnel shall be allowed to have access to the antenna tower. The radiofrequency source must be turned off whenever service personnel are working in areas where the power density levels are greater than the exposure limits stated above. Moreover, the antenna must not be activated in case of repair or maintenance work or whenever service personnel need to approach the antenna at less than the specified safe distances from the 3G2100 antenna.
- Should there be modifications in the RF transmission system that could affect the power density levels in the facility, the CDRRHR must be notified in writing prior to operation of the modified design.
- 4. Warning signs must be placed at strategic locations in the facility.
- A radiation safety officer who has undergone RF radiation safety seminar must be designated.
- The contractor/supplier or owner must undertake measurements to generate a radiofrequency radiation map.

## B. From the Office of the City Engineer/Building Official

In the site acquisition and design of the structure the minimum distance between two (2)
different towers and all existing laws and regulations of agencies involved in regulating the
erection of telecommunication towers must be strictly taken into consideration.

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to approve the request of Smart Communications, Inc. to construct, install, operate and maintain a Cell Site Tower and Telecommunication Facilities at the lot owned by Mr. and Mrs. Joel S. Narag located at Carig Sur, Tuguegarao City.

On motion of Hon. Kendrick S. Calubaquib, duly seconded by Hon. Grace B. Arago and without the presence of Hon. Maila Rosario T. Que who asked permission to leave early, CITY RESOLUTION NO. 207-2018 was APPROVED under suspended rules.
