**CITY RESOLUTION NO. 208-2018**

**RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA)  
 BETWEEN THE LOCAL GOVERNMENT UNIT OF TUGUEGARAO CITY,  
 THE NATIONAL POLICE COMMISSION (NAPOLCOM) RO2 AND THE  
 TUGUEGARAO CITY POLICE STATION (TCPS) AND AUTHORIZING THE CITY MAYOR,  
 HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE  
 TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF AGREEMENT**

**WHEREAS**, the National Police Commission (NAPOLCOM), in line with Section 2 of Republic Act No. 8551, is instituting Community and Service-Oriented Policing as the foundation and backbone of community-oriented policing and crime prevention in the country;

**WHEREAS**, the Department of the Interior and Local Government (DILG) is pushing for the strengthening of the Peace and Order Councils (POCs) of LGUs (in Memorandum Circular) through the adoption of Peace and Order and Public Safety (POPS) planning, a methodical process that will develop a plan responsive to the local criminality and other security and public safety issues and supportive of the LGUs Comprehensive Development Plan;

**WHEREAS**, Section 64 of Republic Act No. 8551 also provides that the Governors and Mayors, upon having been elected and having qualified as such, are automatically "*deputized as representatives of the NAPOLCOM in their respective jurisdictions*";

**WHEREAS**, the International Center for Innovation, Transformation, and Excellence in Governance (INCITEGov) is supporting the DILG in promoting the POPS Planning and in drafting guidelines in developing POPS Plan and will be supporting the NAPOLCOM in integrating CSOP Framework in the POPS Plan;

**WHEREAS**, the Tuguegarao City Police Station is responsible for the maintenance of peace and order in Tuguegarao City, in coordination with other law enforcement agencies to appropriately address the problems of criminality and internal security;

**WHEREAS**, the City Government of Tuguegarao has been strengthening its systems improvement through different programs including Oplan Bakal, Oplan Sita, Oplan Visa and Oplan Linis-River Banks.


**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement to be entered into by and among the Local Government Unit of Tuguegarao, the National Police Commission (NAPOLCOM) RO2 and the Tuguegarao City Police Station.

**RESOLVED FURTHER**, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement.
