CITY RESOLUTION NO. 209-2018

RESOLUTION APPROVING THE REPROGRAMMING OF THE INSTALLATION OF 4-SIDED DIGITAL BILLBOARD AT TANZA JUNCTION, TUGUEGARAO CITY UNDER THE CAPITAL OUTLAY FOR CY 2018 TO INSTALLATION OF 2-SIDED DIGITAL BILLBOARD AT THE 3rd FLOOR AND 4th FLOOR OF TUGUEGARAO CITY COMMERCIAL CENTER, CORNER BONIFACIO STREET AND GONZAGA STREET, TUGUEGARAO CITY

WHEREAS, there is a proposed project of the City Government titled "*Installation of 4-sided digital billboard at Tanza Junction, Tuguegarao City under the Capital Outlay for CY 2018;*"

WHEREAS, Engr. Danilo U. Tabilas, District Engineer of the Cagayan Third Engineering District of the Department of Public Works and Highways (DPWH), has certified that there is an ongoing Data Gathering, Surveys and Investigations for the proposed improvement of Tanza Junction, Tuguegarao City funded under FY 2016 RA 10717 Extended Regular 2016 Continuing Appropriation;

WHEREAS, the proposed project of the City Government 4-sided digital billboard is no longer feasible considering that there is a proposed improvement of Tanza Junction, Tuguegarao City under the Cagayan Third Engineering District of the DPWH;

WHEREAS, the City Mayor has requested that the proposed project installation of a digital billboard at Tanza Junction, Tuguegarao City shall be installed instead at the Tuguegarao City Commercial Center corner Bonifacio Street and Gonzaga Street, Tuguegarao City;

WHEREAS, instead of a 4-sided digital billboard, it shall become a 2-sided digital billboard;

WHEREAS, the 2-sided digital billboard is purposely to promote the programs, projects and activities of the City Government and for other advertisement and information purposes;

WHEREAS, the proposed project for the installation of a 2-sided digital billboard at the Tuguegarao City Commercial Center corner Bonifacio Street and Gonzaga Street, Tuguegarao City is duly supported by a program of work;

WHEREAS, the City Budget Officer has certified that the amount of Eleven Million Pesos (P11,000,000.00) for the installation of a 4-sided digital billboard at Tanza Junction, Tuguegarao City is free from any obligation;

WHEREAS, there is a need to reprogram the amount of Eleven Million Pesos (P11,000,000.00) intended for the installation of a billboard at Tanza Junction, Tuguegarao City to Tuguegarao City Commercial Center corner Bonifacio Street and Gonzaga Street, Tuguegarao City for its proper implementation.


