CITY RESOLUTION EARNESTLY REQUESTING CAGAYAN I ELECTRIC COOPERATIVE (CAGELCO I) TO REPLACE ITS DILAPIDATED, ROTTEN/SECONDARY POLES

WHEREAS, Tuguegarao City is considered a regional center because almost all government offices and state, colleges and universities are located herein;

WHEREAS, as a consequence of the above, lots of businesses continuously open which have also increased the number of consumers of CAGELCO through the years, hence, there were already lots of dilapidated and rotten poles which pose risks and danger to the public;

WHEREAS, there is an urgent need to request CAGELCO for the replacement of dilapidated, rotten/secondary electric poles in order for the realization of Tuguegarao City Government's mandate of protecting and preserving the lives and properties of its constituents;

WHEREAS, with the rapid development of Tuguegarao City, it is necessary for CAGELCO to be prepared ahead of time of their services for electricity in order to effectively cater to the growing population of the people in the City;

WHEREAS, the committee during its meeting found the request to be in order and with merit, hence has favorably approved the same;

WHEREAS, after the presentation and adoption of Committee Report No. 137-2018, the Seventh City Council during its 95th Regular Session deemed it proper, necessary and beneficial to the constituents of the City to approve the said request;

WHEREAS, the National Electrification Administration shall fund for the replacement of the dilapidated, rotten/secondary poles to be supervised by the Energy Regulatory Commission.




