CITY RESOLUTION NO. 212-2018

A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE OFFICE OF THE CIVIL DEFENSE AND GRANTING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN THE SAID MEMORANDUM OF AGREEMENT

WHEREAS, the referral *“Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Office of the Civil Defense-RO2”* was endorsed to the Seventh City Council;

WHEREAS, the joint Committee on Rules, Laws and Ethics and Committee on Public Safety and Order and Disaster Preparedness, to which the matter was referred to, met on August 02, 2018 to discuss the subject referral with the resource persons;

WHEREAS, the Memorandum of Agreement is pursuant to Section 2 (h) and Rule 6 Section 4 (17) of R.A. No. 10121, otherwise known as the *“Philippine Disaster Risk Reduction and Management Act of 2010”*;

WHEREAS, the City Disaster Risk Reduction and Management Council (CDRRMC) passed and approved on June 25, 2018 Council Resolution No. 03, series of 2018 titled *“Resolution Approving the Memorandum of Agreement between the Tuguegarao City Government and Office of Civil Defense RO2;”*

WHEREAS, the Office of the Civil Defense has programmed to preposition Non-Food Items as a proactive approach in disaster response;

WHEREAS, as per information from the Head of the CDRRMO, the one hundred fifty (150) family packs for Tuguegarao City were already delivered in advance by the Department of Science and Technology (DOST) Office which are currently stored at the second floor of the Old City Hall;


