CITY RESOLUTION NO. 214-2018

RESOLUTION APPROVING THE TUGUEGARAO CITY CORN ROAD MAP AND CLUSTER DEVELOPMENT PLAN FOR FISCAL YEAR 2018-2022 FOR THE NATIONAL CORN QUALITY ACHIEVERS AWARDS COMPETITION

WHEREAS, the Tuguegarao City Corn Road Map hopes to provide direct and lasting solutions to the country's need for poverty alleviation, food security, income enhancement especially for farmers and fisher folk, social equity and global competitiveness within the framework of people empowerment and sustainable development;

WHEREAS, Tuguegarao City, the capital of Cagayan and the Regional Center of Cagayan Valley, is the oldest major trade, education and government center in the Northeast Luzon. It has all the facilities, amenities and attractions of a city with a laid back atmosphere and pace in its agriculture Barangays, with a centrally located Poblacion providing a bustling commercial and service center for Tuguegarao City and its environs;

WHEREAS, the vision of Tuguegarao City Corn Road Map FY 2018-2022 is to increase the production of quality corn by providing mechanized farming facilities to corn farmers to increase their income and productivity, and to enhance existing farmers' corn-based farming systems through introduction of improved technologies through the concerted efforts of the Local Government Unit of Tuguegarao City in partnership with national line agencies and Non-Government Organizations (NGOs) in the implementation of the programs, projects and activities in the cluster areas;

WHEREAS, the City Agriculture Office has signified its interest and desire to participate in the National Corn Quality Achievers Awards Competition under the Department of Agriculture;

WHEREAS, one of the requirements to the said competition is the Corn Road Map and Cluster Development Plan Fiscal Year 2018-2022 approved by the Seventh City Council;



WHEREAS, the Committee on Agriculture and Food met on August 02, 2018 to deliberate on the subject referral titled *“Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, on the recommendation of the City Agriculturist, Ms. Evangeline P. Calubaquib, on the Tuguegarao City Corn Road Map and Cluster Development Plan FY 2018-2022;”*


