CITY RESOLUTION NO. 215-2018

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE DEPARTMENT OF LABOR AND EMPLOYMENT RO2 FOR THE DOLE LIVELIHOOD (KABUHAYAN) PROGRAM AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE CITY GOVERNMENT THE SAID MEMORANDUM OF AGREEMENT

WHEREAS, the Department of Labor and Employment (DOLE) is mandated to promote gainful employment opportunities, develop human resources, protect workers and promote their welfare, and maintain industrial peace;

WHEREAS, the DOLE will provide a capacity building facility on livelihood and entrepreneurial ventures for the workers in the informal economy and the vulnerable groups of workers under the DOLE Livelihood (Kabuhayan) Program, pursuant to the provisions of DO No. 137, series of 2014;

WHEREAS, DOLE RO2 has been given the responsibility to implement the DOLE Livelihood (Kabuhayan) Program and shall implement the livelihood intervention in the City of Tuguegarao, Province of Cagayan, in partnership with the LGU-Tuguegarao City as accredited co-partner;

WHEREAS, Tuguegarao City Government has been accredited by DOLE to be capable and experienced in implementing the proposed project of the 20 Persons With Disabilities (PWDs) and 18 beneficiaries, particularly for the Sari-Sari Stores, Tailoring, Piggery, Rice Retailing, Product Retailing, Carpentry, Vendor, Barber and Welder of Tuguegarao City;

WHEREAS, the beneficiaries for the piggery shall be determined following the set of criteria below:

1. The barangay is not covered by City Ordinance No. 04-2003 titled "*An Ordinance Penalizing the Raising and Maintenance of Pigs in Certain Areas of Tuguegarao City*";
2. The beneficiary is capable of maintaining the project; and,
3. The beneficiary must undergo the necessary training.


NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement to be entered into between the Tuguegarao City Government and the Department of Labor and Employment, Regional Office No. 02 (DOLE-RO2) for the DOLE Livelihood (Kabuhayan) Program.

RESOLVED FURTHER, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement.


On joint motion, **CITY RESOLUTION NO. 215-2018** was **APPROVED** under suspended rules.
