CITY RESOLUTION NO. 217-2018

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE DEPARTMENT OF LABOR AND EMPLOYMENT RO2 FOR THE DOLE LIVELIHOOD (KABUHAYAN) PROGRAM AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE CITY GOVERNMENT THE SAID MEMORANDUM OF AGREEMENT"

WHEREAS, the Department of Labor and Employment (DOLE) is mandated to promote gainful employment opportunities, develop human resources, protect workers and promote their welfare, and maintain industrial peace;

WHEREAS, the DOLE will provide a capacity building facility on livelihood and entrepreneurial ventures for the workers in the informal economy and the vulnerable groups of workers under the DOLE Livelihood (Kabuhayan) Program, pursuant to the provisions of DO No. 137, series of 2014;

WHEREAS, DOLE RO2 has been given the responsibility to implement the DOLE Livelihood (Kabuhayan) Program and shall implement the livelihood intervention in the City of Tuguegarao, Province of Cagayan, in partnership with the LGU-Tuguegarao City as accredited co-partner;

WHEREAS, Tuguegarao City Government has been accredited by DOLE to be capable and experienced in implementing the proposed project of Sixty-Six (66) beneficiaries, particularly for the Rice Retailing, Ice Production, Sari-Sari Stores, Tailoring, Carpentry, Barber, Street Food Vending, Carinderia, Talipapa, Lugawan/Mamihan and Welding of Tuguegarao City.


