**CITY RESOLUTION NO. 218-2018**

**RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN AND AMONG THE LOCAL GOVERNMENT UNIT (LGU) OF TUGUEGARAO CITY, SECURITY BANK FOUNDATION, INC. (SBFI), ATENEO DE MANILA UNIVERSITY (ADMU) AND DEPARTMENT OF EDUCATION, CITY DIVISION OFFICE FOR THE "BUILD A SCHOOL, BUILD A NATION: THE CLASSROOMS PROJECT" AND GRANTING AUTHORITY TO THE FORMER ACTING CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, AND THE INCUMBENT CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN AND CONCUR FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF TUGUEGARAO CITY THE SAID MOA**

**WHEREAS**, the Security Bank Foundation, Inc. (SBFI), in a letter dated May 17, 2018 which was received by the Office of the City Mayor on June 19, 2018, informed Hon. Atty. Jefferson P. Soriano that the Tuguegarao City is one of the identified beneficiaries of its "Build a School, Build a Nation: The Classrooms Project";

**WHEREAS**, one of the two (2) chosen school beneficiaries for the said project in Tuguegarao City is Pallua Elementary School;

**WHEREAS**, at the time the said letter was received, Hon. Bienvenido C. De Guzman II was the Acting City Mayor;

**WHEREAS**, the then Acting City Mayor Hon. Bienvenido C. De Guzman II indorsed the said letter on June 19, 2018, together with the draft proposed Memorandum of Agreement (MOA) of the SBFI, to the Seventh City Council requesting for the approval thereof and the authority to sign for and on behalf of the Local Government Unit of Tuguegarao City the said MOA;

**WHEREAS**, after the presentation and adoption of Committee Report No. 115-2018, the Seventh City Council approved City Resolution No. 191-2018 titled "*Resolution Expressing The Profound Gratitude Of The Tuguegarao City Government To Security Bank Foundation, Inc. (SBFI) And Ateneo De Manila University (ADMU) For Having Considered Tuguegarao City As A Beneficiary For Their Project*

"Build A School, Build A Nation: The Classrooms Project" during its 90<sup>th</sup> Regular Session held on July 02, 2018 while awaiting for the final draft of the MOA to be submitted by the SBFI;

**WHEREAS**, at the time the said resolution was approved, it was still Hon. Bienvenido C. De Guzman II who was then the Acting City Mayor;

**WHEREAS**, on July 19, 2018, the City Mayor, Hon. Jefferson P. Soriano, was reinstated and assumed the Office of the City Mayor, Tuguegarao City;

**WHEREAS**, the final copy of the MOA was transmitted by the SBFI to City Vice Mayor Hon. Bienvenido C. De Guzman II on August 07, 2018, with the signature of the Chairman of the SBFI already affixed therein and the name of Hon. Bienvenido C. De Guzman II still indicated/appears as the signatory for the City Government of Tuguegarao City, in his capacity as the then Acting City Mayor;

**WHEREAS**, according to the Legal Department of SBFI, to return the said MOA to the SBFI in order to make the necessary corrections so as to change the authorized signatory for the City Government of Tuguegarao City will entail time causing delay to the project;


**WHEREAS**, considering that time is of the essence and the project is beneficial to the people of Tuguegarao City, it is more prudent that the Seventh City Council will grant authority to the City Vice Mayor, Hon. Bienvenido C. De Guzman II, in his capacity as the then Acting City Mayor and to City Mayor, Hon. Atty. Jefferson P. Soriano, to sign and concur for and on behalf of the Local Government Unit of Tuguegarao City the aforementioned MOA.

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement (MOA) Between and Among the Local Government Unit (LGU) of Tuguegarao City, Security Bank Foundation, Inc. (SBFI), Ateneo de Manila University (AdMU) and Department of Education, Division Office for the "Build A School, Build A Nation: The Classrooms Project" and Granting Authority to the City Vice Mayor, Hon. Bienvenido C. De Guzman II, in his capacity as the then Acting City Mayor and the Incumbent City Mayor, Hon. Atty. Jefferson P. Soriano, to sign and concur for and on behalf of the Local Government Unit of Tuguegarao City the said MOA.


On motion of Hon. Raymund P. Guzman, duly seconded by Hon. Kendrick S. Calubaquib, with the abstention of Hon. Mary Marjorie P. Martin-Chan and Hon. Maila Rosario T. Que, **CITY RESOLUTION NO. 218-2018** was **APPROVED** under suspended rules.
