# CITY RESOLUTION NO. 225-2018

# RESOLUTION APPROVING THE REQUEST OF RADIANT BAY GAMES AND ENTERTAINMENT CORPORATION FOR A RESOLUTION OF NO OBJECTION (RONO) AS A PRE-REQUISITE IN THE ESTABLISHMENT AND OPERATION OF AN ELECTRONIC GAMES/E-BINGO AT THE EDITHA'S ARCADE, BALZAIN WEST (CENTRO 12), TUGUEGARAO CITY

WHEREAS, Ms. Jenifer Kaycee Almazora, Representative, Radiant Bay Games and Entertainment Corporation has requested for a Resolution of No Objection (RONO) from the Sanggunian as part of the requirements of the Philippine Amusement and Gaming Corporation (PAGCOR) in the establishment and operation of an Electronic Games/E-Bingo at the Tuguegarao City Commercial Center, Tuguegarao City;

WHEREAS, Ms. Jenifer Kaycee Almazora has complied with the following documentary requirements:

- A. Philippine Amusement and Gaming Corporation (PAGCOR) Application Form for the establishment of Gaming Site
- B. Lease of Contract between Editha's Arcade and Radiant Bay Games and Entertainment Corporation
- C. Special Power of Attorney authorizing Ms. Jenifer Kaycee Almazora to represent Radiant Bay Games and Entertainment Corporation
- D. Site Floor Plan
- E. Certificate of Incorporation
- F. Unified Registration Record (URR)
- G. Articles of Incorporation
- H. DTI Registration
- I. Mayor's Permit



WHEREAS, the management of Radiant Bay Games and Entertainment Corporation shall prioritize employment of qualified residents from Tuguegarao City and that the gaming place be assured with utmost security;

WHEREAS, the failure of Radiant Bay Games and Entertainment Corporation to follow the operational procedures of PAGCOR and/or its engagement in unscrupulous transactions shall be ground for the revocation and cancellation of its RONO;

WHEREAS, the operation of Radiant Bay Games and Entertainment Corporation shall be governed and subjected to the provisions of local laws and ordinances of Tuguegarao City;

WHEREAS, Committee Report No. 147-2018 of the Committee of the Whole recommending the passage of a Resolution of No Objection (RONO) as a pre-requisite in the establishment and operation of an Electronic Games/E-Bingo at the Editha's Arcade, Balzain West (Centro 12), Tuguegarao City was duly adopted during the 98<sup>th</sup> Regular Session of the Sangguniang Panlungsod.

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to approve the request of Radiant Bay Games and Entertainment Corporation for a Resolution of No Objection (RONO) as a prerequisite in the establishment and operation of an Electronic Games/E-Bingo at the Editha's Arcade, Balzain West (Centro 12), Tuguegarao City, subject, however, to compliance with the PAGCOR guidelines on the operation of Electronic Games/E-Bingo and other National/Local Laws and Ordinances.

On motion of Hon. Raymund P. Guzman, duly seconded by Hon. Kendrick S. Calubaquib, with the abstention of Hon. Maila Rosario T. Que and Hon. Mary Marjorie P. Martin-Chan, and inhibition of Hon. Anthony C. Tuddao, CITY RESOLUTION NO. 225-2018 was APPROVED under suspended rules. x-x-x
